OFFICE ORDER

The provisions for medical treatment of Company employees who are not covered under ESI is hereby revised as detailed below in compliance to Resolution No. 477 – 18.8 of Board of Directors in the meeting on 29.12.2016:-

- (1) The provisions of Medical Attendance Rules,2000 as enumerated at Rule No.12.1 to 12.20 will continute to apply as usual.
- (2) Following provisions are hereby added as new Rule No.12.22 after existing Rule No.12.21 of Medical Attendance Rules, 2000, as printed below:-

"Rule No.12.22" :-

(i) The company empanels following private hospitals for medical treatment of employees of the Company as per rules and the pattern, rates and other provisions as approved by Central Government Health Scheme (CGHS) and applied by the State Government for their Government servants, detailed and enumerated, as referred under Circular No.F6(2)FD(Rules)/2013 dated 08.09.2015 issued by Finance Department (Rules Division), Government of Rajasthan. Amendments and subsequent revisions issued by the State Government will also apply to the Company.

- Reimbursement will be made on prescribed rates/charges as applicable by such respective hospitals as mentioned above or CGHS rates whichever is (ii) less.
- The medicines prescribed by medical practitioners of such empanelled hospitals may be purchased from authorized medical shops located within (iii) the premises of the hospitals. In case medicines are not available then such medicines shall be purchased from Co-operative shops operated by CONFED/PSUs. The employee may purchase such medicines from other private shops in case of non availability of such medicines from Cooperative shops after getting/issued an Non Availability Certificate (NAC) as per established system.
- The earlier approved hospitals viz. Tantia Hospital, Sri Ganganagar, Mittal Hospital, Alwar, T.K. Hospital, Jaipur, Mangalam Hospital, Jaipur are (iv) hereby removed from list of empanelled hospital with immediate effect. In case of on going indoor medical treatment of any employee it will be allowed till his/her discharge from the hospital. Similarly outdoor patients may continue their existing treatment upto 31.03.2017.
- Following existing empanelled hospitals will continue to provide medical facility to the employees of the Company as per existing terms, conditions (v) and rates as detailed vide respective orders issued in their respect mentioned below:-
