2. *Provisions of notification no. F.1(8)/FD/GF&AR/2011 Dated 19.11.2015 shall be applicable as subject matter of procurement is a scheduled item which is to be procured only from Micro And Small Enterprises Situated In Rajasthan Only.*

- iii) Bidder shall invariably have to enclose valid Capacity Assessment Certificate issued by concerned MSME/ Valid certificate of District Industries Centre of Rajasthan or satisfactory completion certificate of supply exceeded to that of capacity made against supply schedule / purchase order in any Government /Autonomous / Reputed Private Organization / Department or capacity assessment certificate issued by a Chartered Engineer along with bid. In absence of the same, bid shall be rejected prima-facie.
- iv) 4 % of such procurement shall be earmarked for procurement from local micro and small enterprises owned by member of scheduled caste and scheduled tribe in Rajasthan.
- v) *Bids received from sources other than those specified in clause 3(a) shall not be taken into consideration.*
- vi) The contract for supply of goods to the enterprises included in the category mentioned at clause 3 (a) (Micro and Small Enterprises what so ever the case may

Important Instructions :- The Law relating to procurement "The Rajasthan Transparency in Public procurement Act, 2012" [hereinafter called the Act] and the "Rajasthan Public Procurement Rules, 2013" [hereinafter called the Rules] under the said Act have come into force which are available on the website of State Public Procurement Portal <http://sppp.rajasthan.gov.in>. If there is any discrepancy between the provision of the Act/Rules and this Bidding Document, the provisions of the Act and the Rules shall prevail.

01. Eligibility Criteria for participation in bid :

02. Specifications for Corrugated Boxes (Cartons): -

A. Specifications for Corrugated Boxes (Cartons) of Glass Nips (180 ml)

Corrugated Boxes (Cartons) made from Semi Craft paper of minimum 16 BF of any reputed mill having 3 Ply for packing, 48 Nips of 180 ml (Nips). Each corrugated Box should have single plates (Bottom). The Corrugated Box should be duly printed in single colour on all four sides of the corrugated box. The specification of the Corrugated Boxes shall be as under:-

a) Cartons: For Glass Nips 180 ML

I. Size For Nips (180 ml Nips) (L x W x H) : 450 mm x 310 mm x 150 mm

II. Bottom Plate For Nips (180 ml Nips) (L x W) : 430 mm x 295 mm

b) Weight of the Cartons including Single Bottom Plate (All of 100 GSM):

I. For Nips (180 ml Glass Nips) : 305 Grams (minimum weight)

c) The Cartons including plates shall be tested for Bursting Strength of minimum 3.8 Kg/Sq. cm and GSM Testing (As per BIS) from RSGSM Laboratory at Jhotwara.

d) The Boxes should be made of 3 ply of minimum 100 Gsm each by using Semi Craft paper and boxes of Glass Nips are printed in Single Colour (Red) on all four sides as per our design. The Boxes shall have one stitch on any one corner of the box. Bottom plate should be three ply, minimum 100 Gsm. The name of manufacturer along with address & seal shall have to be printed on each carton.

B. Specifications for Corrugated Boxes (Cartons) of Glass Bottles (750 ML)

Corrugated Boxes (Cartons) made from Semi Craft paper of minimum 16 BF of any reputed mill having 3 Ply for packing, 12 bottles of 750 ml (Bottle). Each corrugated Box should have single plates (Bottom). The Corrugated Box should be duly printed in single colour on all four sides of the corrugated box. The specification of the Corrugated Boxes shall be as under:-

a) Cartons: For Glass Bottles 750 ML

I. Size For Bottle (750 ml bottles) (L x W x H): 310 mm x 230 mm x 275 mm

II. Bottom Plate For Bottle (750 ml bottles) (L x W): 290 mm x 210 mm

b) Weight of the Cartons including Single Bottom Plate (All of 100 GSM):

I. For Bottle (750 ML Glass bottles) : 210 Grams (minimum weight)

c) The Cartons including plates shall be tested for Bursting Strength of minimum 3.8 Kg/Sq. cm and GSM Testing (As per BIS) from RSGSM Laboratory at Jhotwara.

- d) The Boxes should be made of 3 ply of minimum 100 Gsm each by using Semi Craft paper and boxes of Glass Bottle are printed in Single Colour (Red) on all four sides as per our design. The Boxes shall have one stitch on any one corner of the box. Bottom plate should be three ply, minimum 100 Gsm. The name of manufacturer along with address & seal shall have to be printed on each carton.

C. Specifications for Corrugated Boxes (Cartons) of Pet Nips (180 ml)

Corrugated Boxes (**Cartons**) made from Semi Craft paper of minimum 16 BF of any reputed mill having 3 Ply for packing, 48 Nips of 180 ml Nips. The Corrugated Box should be duly printed in single colour on all four sides of the corrugated box. The specification of the Corrugated Boxes shall be as under:-

- a) **Cartons for Pet Nips 180 ML**
- I. Size For Nips (180 ml Pet Nips) (L x W x H) : 370 mm x 340 mm x 138 mm
- b) Weight of the Cartons (sheets must be 120 gsm):
- I. For Nips (180 ml Pet Nips) : 270 Grams (minimum weight)
- c) The Cartons shall be tested for Bursting Strength of minimum 4.6 Kg/Sq cm and GSM Testing (As per BIS) from RSGSM Laboratory at Jhotwara
- d) Mono Gram Length 120 mm, Width 140 mm
- e) The boxes should be made of 3 ply and all sheets must be minimum 120 gsm semi kraft paper brown colour and boxes of Pet Nips are printed in Single Colour (Red) on all four sides as per our design. The Boxes shall have one stitch on any one corner of the box. The name of manufacturer along with address & seal shall have to be printed on each carton. **The sample may be seen in the office on any working day before submission of the bid.**

03. **Rate:**-Single Rate F.O.R. at godown/warehouse of reduction centers should be quoted in financial bid (Online). GST shall be shown separately. If GST will not be shown separately, the quoted rate shall be assumed inclusive GST.
04. **Technical Evaluation:** - The bids will technically be evaluated first. The Bidder will have to provide complete Profile of the Company/ organization including audited balance sheets details of Plant & Machinery, Capacity utilization, supply, samples of **Corrugated Boxes** and other details as per requirement of check list (Technical Bid).
05. **Resolution of the cases of variation in specification beyond permissible limits:** **Corrugated Boxes** having variation beyond permissible limits to prescribed specifications then supply shall not be accepted and shall be liable for rejection and shall be taken back by the supplier at their own expenses within 15 days of issue of letter to this effect.
06. **Inspection of factory/ works of the bidder:** The RSGSM Ltd. will be free to carry out sudden inspection of the factory/ works of the bidder before or during

the supply contract without prior intimation. If the factory is found un-functional or the details of the plant and machinery if found otherwise than as mentioned in the bid, bid security/security deposit may be forfeited with 18% GST.

07. **Inspection of supplied goods by the bidder:** Company reserves the right to conduct sudden/random inspection of the supplied goods to check the quality of supplied items at RC or any place even after the final payment. If qualities of supplied goods are not found up to the mark, rejected **Corrugated Boxes** shall be deformed(विकृत करना) by in charge of reduction center under its video recording, copy of which (videographer) shall be sent to head quarter and then after same may be handed over to supplier. If the supplier will not take the rejected goods within 15 days then company will be free to destroy/sale the same on the cost of supplier. Cost of destroy/sale shall be decided on actual expenditure incurred reported by In charge of reduction center. The suitable deduction shall be made from the bill. The decision of the RSGSM will be final and binding to the supplier firm. On account of rejection no any claim shall be accepted.
08. **Verification:** -Verification of every consignment of **Corrugated Boxes** shall be done on random basis at RC level.
09. **Testing :-**
- i. The sample of **Corrugated Boxes** from every consignment will be got tested from the RSGSM laboratory, Jhotwara, Jaipur /Government authorized laboratory or any reputed Private laboratory for all the parameters as specified in bid and contract. If supplier's representative is not available within three days on receipt of consignment, the Company shall have right to draw the necessary sample and get it tested. In this case the supplier shall not claim any benefit, on ground of the absence. The testing fee paid shall be borne by the Company. In case of rejection of article found sub-standard on testing, the testing fee so paid will be recovered from the supplier.
 - ii. The company may get tested the sample of **Corrugated Boxes** from any reputed laboratory accredited from NABL (National Accreditation Board for Testing and Calibration Laboratories).
 - iii. After testing of sample if it is found that sample does not conform the specifications given in bid document at more than three occasions under this contract, in that case Security Deposit will be forfeited with 18% GST and contract will invariably be terminated without any hearing or giving notice.
10. **Payment:** - 100% payment of bills shall be released by H.O. Jaipur for supplies made on receipt of verified bills from the RC along with test report from Jhotwara/ Authorized Laboratory dispatch note and receipt note. While verifying the bills, respective RC must check the shape, size, weight, transparency etc.

11. The supplier shall have to ensure proper quality as per specification of Corrugated boxes (Carton) supplied. In case of testing of Corrugated Boxes, if Bursting Strength / GSM are found below permissible limits, the deduction shall be made from the bills in following manner: -

(01)	Variation up to 2.5% in weight of box with plate on lower side	@10% +18% GST
(02)	Variation up to 2.5% in minimum Bursting Strength (Box)	@10% +18% GST
(03)	Variation in minimum Bursting Strength (Plate)	@10% +18% GST
(04)	Print and name of manufacturer on box not upto the mark	@10% +18% GST

If variation in any of the parameters of weight and/or Bursting Strength is found more than the permissible limit of 2.5% on lower side, the supply shall be liable to be rejected at the risk & cost of supplier.

Note: - The Bursting Strength & Weight of Corrugated Boxes are co-related, so deduction shall be made on one parameter only, which is on higher side.

However, in case of certain exigency, if the material of below specification (beyond permissible limits) is consumed with the permission of Head Office, DIC shall have power to decide deduction as well as quantum of penalty on account of supply of substandard material.

12. **Risk & Cost:** The supplier shall have to adhere strictly to supply schedule. In case of not maintaining supply as per schedule then material may be procured from any source at any time on the risk and cost of the supplier.
13. **Approximate Quantity:-** The approximate and tentative quantity of subject matter of procurement will be as detailed below and the same shall be subject to variation as per Rajasthan Government directives and policies :-

Note:-The quantity of supply of Corrugated Boxes may be within variance of $\pm 1\%$ of supply schedule.

14. **Estimated Value of Bid:** Total estimated value of bid is approx. Rs. 8.89 Crore.
15. **Change in specification:** The management reserves the right to change the specification, size, design and quantity anytime during the contract period. If the

management decides to change in specifications and weight then price of box will be reduced proportionate to decrease in weight. If the decision of changing the basic packaging pattern, based on R&D, is taken then it is the liberty of the procuring entity to switch over such change.

16. **Bid Security:** Total estimated cost, based on total bid quantity, has been calculated ₹ 8.89 Crore, on the basis of which bid security declaration should be submitted by the bidder.
17. **Recovery:** Recovery for unsupplied quantity shall be 10% of value of unsupplied quantity+ GST @ 18% there on.
18. If any supplier fails to supply or makes in adequate supply to that of given as per supply schedule inconsequent three months period without any satisfactory reason, then agreement could be terminated and his security amount will be forfeited with 18% GST.
19. **Variation in quantity:** variation up to $\pm 1\%$ shall be allowed in total quantity to be supplied for the purpose of completion of the supply order.
20. **Period**—The period of rate contract shall be one year and that may be extended on same price, terms and conditions for a period not exceeding 3 months.
21. **A rate contract shall be entered, for price without a commitment for quantity, place and time of supply of subject matter of procurement, with the bidder of lowest priced bid or most advantageous bid.**
22. **Dividing quantities among more than one bidder at the time of award-** As a general rule all the quantities of the subject matter of procurement shall be procured from the bidder, whose bid is accepted. However, when it is considered that the quantity of the subject matter of procurement to be procured is very large and it may not be in the capacity of the bidder, whose bid is accepted, to deliver the entire quantity or when it is considered that the subject matter of procurement to be procured is of critical and vital nature, in such cases, the quantity may be divided between the bidder, whose bid is accepted and the second lowest bidder or even more bidders in that order, in a fair, transparent and equitable manner at the rates of the bidder, whose bid is accepted if such condition is specified in the bidding documents. Counter offer to first lowest bidder (L1), in order to arrive at an acceptable price, shall amount to negotiation However, any counter offer thereafter to second lowest bidder (L2), third lowest bidder (L3) etc., (at the rates accepted by L1) in case of splitting of quantities, as pre- disclosed in the bidding documents, shall not be deemed to be a negotiation.

23. Management reserves the right to reject the bid of bidders whose report have been found unsatisfactory any time during the supply contract or Bidders, its affiliates and associates, who have been debarred for any reason anytime during the supply

contract for any item. Any Manufacturer found manufacturing illicit Corrugated Boxes of RSGSM is liable for legal action by the Company.

24. **Breakage/defects:-** Transit breakage/ cost of defective Corrugated Boxes shall be borne by supplier which shall be detect during the process of filling and no payment of such defective Corrugated Boxes shall be made to the bidder.
25. Date of receipt of material at the destination shall be considered for calculating recovery of liquidated damages.
26. The financial bid of such the bidders whose technical bid is found O.K. (Qualified) shall only be opened on later date which shall be communicated through eproc automated messaging system.
27. Bidder should enclose certified copy of all the required documents as per checklist enclosed with Bid form.
28. The monthly supply schedule for quantities shall be given from time to time as per requirement.
29. Every bidder shall have to provide its per day and per month production capacity and shall submit evidence/proof in support of justification of offered production capacity in Corrugated Boxes such as work orders of Government/Autonomous bodies/ Private firms under which supply has been made in each year for last two years exceeded to that of offered capacity.
30. The turnover of bidder in Corrugated Boxes should be average 150.00 Lakhs per year in any two years out of last three years, in support of which bidder shall have to submit copy of final accounts audited by CA.
31. Bidder should offer a minimum 33 % quantity of bid for each type of corrugated boxes for which they willing to submit their bid. Offered quantity less than 33 % quantity of bid shall not be considered and the bid shall be liable for rejection.
32. RSGSM will be free to issue Supply Schedule for the quantity as per production capacity shown by the bidder in technical bid checklist.
33. **Calculation of LD:** If supplies are taken at more than one place during one supply schedule then supplies received in total at various ordered places at the end of period of supply schedule shall be considered for calculating Liquidated Damages.
34. **Cancellation:** In case RSGSM do not require part or entire ordered quantity, due to any reason, it may cancel the part or entire order during the period of contract and/or any extended period, for which no claim of the supplier shall be entertained.
35. A rate contract shall be entered, for price without a commitment for quantity, place and time of supply of subject matter of procurement, with the bidder of lowest priced bid or most advantageous bid.
36. **If there is any contradiction in provision of general terms and conditions and that of in special terms & conditions, then provision of special terms &**

conditions shall prevail. In case of dispute regarding interpretation of any terms and conditions in the bid document the same should be got clarified by the bidder before submitting the bid. At any stage of the bid process, the decision of the management shall be final and binding on all the bidders. Any request for changing of any conditions/quoted price or inclusion of any document etc after submitting the bid document, unless called for by procuring entity in writing, shall not be entertained.

If any declaration given by the bidder after taking oath is found false or manipulated later on then the bid of such bidders shall be cancelled at the moment with forfeiture of bid security or performance security deposit whatsoever and the bidder shall be debarred from participation in bid in future for a period not exceeding three years, further legal proceedings shall be initiated against such bidders.

GENERAL TERMS & CONDITIONS OF BID AND CONTRACT

1. The bidder shall have to carefully study and understand the conditions, specifications, size, make etc. of the goods to be supplied. If he has any doubt about the meaning of any term, condition or specifications etc he should refer to officer in charge and get clarification. The decision of the Company regarding interpretation of the conditions and specifications shall be final and binding on the bidders.
2. Bidders are hereby explicitly warned that Individuals signing the bid must specify as follows :-
 - a. Whether signing as "sole proprietor of the firm?"
 - b. Whether signing as registered active partner of the firm?
 - c. Whether signing for the firm on the basis of power of attorney?
 - d. In case of companies and registered firms, whether signing as Secretary, Manager, Partner, Director, etc. will submit an authorization from the company to do so. A copy of any document under which such authority is given should be forwarded with the bid if a copy has not already been sent to the company.
3. Bidder, who is not registered under the GST Act, prevalent in the Rajasthan state or where its business is located, may not be eligible for Bid. The GST Registration number should invariably be quoted.
4. If a bidder imposes conditions which are in addition to or in conflict with the conditions mentioned herein, his bid may be rejected.
5. Rates quoted must be inclusive of all charges and taxes except GST which shall be added at the prevailing rates. The rates quoted must be F.O.R. Distillery/ Warehouses of reduction centers.
6. The Bidder shall not assign or sublet his contract or any part thereof to any other agency.
7. The Bidder should Sign and upload Bid Form at the end of each page as token of his acceptance of all the terms and conditions of the Bid.
8. **Bid security- Provided that, during the period commencing from the date of commencement of the Rajasthan Transparency in Public Procurement (Second Amendment) Rules, 2020 to 31.12.2021, in lieu of bid security a Bid Security Declaration shall be taken.**
 - i. In case of open competitive bidding, two-stage bidding, rate contract, electronic reverse auction, bid security shall be 2% or as specified by the State Government of the estimated value of subject matter of procurement put to bid. In case of Small Scale Industries of Rajasthan it shall be 0.5% of the quantity offered for supply and in case of sick industries, other than

Small Scale Industries, whose cases are pending with Board of Industrial and Financial Reconstruction; it shall be 1% of the value of bid. Concessional bid security may be taken from registered bidders as specified by the State Government. Every bidder, if not exempted, participating in the procurement process shall be required to furnish the bid security as specified in the notice inviting bids.

- ii. In lieu of bid security, a bid securing declaration shall be taken from Departments' of the State Government and Undertakings, Corporations, Autonomous bodies, Registered Societies, Cooperative Societies which are owned or controlled or managed by the State Government and Government Undertakings of the Central Government.
- iii. Bid security instrument or cash receipt of bid security or a bid securing declaration shall necessarily accompany the sealed bid.
- iv. Bid security of a bidder lying with the procuring entity in respect of other bids awaiting decision shall not be adjusted towards bid security for the fresh bids. The bid security originally deposited may, however, be taken into consideration in case bids are re-invited.
- v. The bid security may be given in the form of cash by RTGS, banker's cheque or demand draft or bank guarantee, in specified format, of a scheduled bank. The bid security must remain valid thirty days beyond the original or extended validity period of the bid.
- vi. Prior to presenting a submission, a bidder may request the procuring entity to confirm the acceptability of proposed issuer of a bid security or of a proposed confirmer, if required. The procuring entity shall respond promptly to such a request.
- vii. The bank guarantee presented as bid security shall be got confirmed from the concerned issuing bank. However, the confirmation of the acceptability of a proposed issuer or of any proposed confirmer does not preclude the procuring entity from rejecting the bid security on the ground that the issuer or the confirmer, as the case may be, has become insolvent or has otherwise ceased to be creditworthy.
- viii. The bid security of unsuccessful bidders shall be refunded soon after final acceptance of successful bid and signing of Agreement and submitting performance security.
- ix. The Bid security taken from a bidder shall be forfeited in the following cases, namely:-
 - a. when the bidder withdraws or modifies its bid after opening of bids;
 - b. when the bidder does not execute the agreement, if any, after placement of supply / work order within the specified period;

- c. when the bidder fails to commence the supply of the goods or service or execute work as per supply / work order within the time specified;
 - d. when the bidder does not deposit the performance security within specified period after the supply / work order is placed; and
 - e. if the bidder breaches any provision of code of integrity prescribed for bidders specified in the Act and Chapter VI of these rules.
- x. In case of the successful bidder, the amount of bid security may be adjusted in arriving at the amount of the Performance Security, or refunded if the successful bidder furnishes the full amount of performance security.
 - xi. The procuring entity shall promptly return the bid security after the earliest of the following events, namely:-
 - a) the expiry of validity of bid security;
 - b) the execution of agreement for procurement and performance security is furnished by the successful bidder;
 - c) the cancellation of the procurement process; or
 - d) the withdrawal of bid prior to the deadline for presenting bids, unless the bidding documents stipulate that no such withdrawal is permitted.

9. Performance security-

- a) Performance security shall be solicited from all successful bidders except the department's of the State Government and undertakings, corporations, autonomous bodies, registered societies, co-operative societies which are owned or controlled or managed by the State Government and undertakings of the Central Government. However, a performance security declaration shall be taken from them. The State Government may relax the provision of performance security in particular procurement or any class of procurement.
- b) The amount of performance security shall be five percent, or as may be specified in the bidding documents, of the amount of supply order in case of procurement of goods and services. In case of Small Scale Industries of Rajasthan it shall be one percent of the amount of quantity ordered for supply of goods and in case of sick industries, other than Small Scale Industries, whose cases are pending before the Board of Industrial and Financial Reconstruction (BIFR), it shall be two percent of the amount of supply order.

3 [Provided that, during the period commencing from the date of commencement of the Rajasthan Transparency in Public Procurement (Amendment) Rules, 2020 to 31.12.2021, the performance security shall be taken as under: -

- (a) 2.5%, or as may be specified in the bidding documents, of the amount of supply order in case of procurement of goods and services and 5% of the amount of work order, in case of procurement of works;
- (b) 0.5% of the amount of quantity ordered for supply of goods, in case of Small-Scale Industries of Rajasthan; and

(c) 1% of the amount of supply order, in case of sick industries, other than Small Scale Industries, whose cases are pending before the Board of Industrial and Financial Reconstruction (BIFR).]

c) Performance security amount exceeded Rs.10.00 Lac shall be furnished in any one of the following forms-

- i) Bank Draft or Banker's Cheque of a scheduled bank;
- ii) Bank guarantee/s of a scheduled bank. It shall be got verified from the issuing bank. Other conditions regarding bank guarantee shall be same as mentioned in the rule 42 of RTPP Rules 2013 for bid security;
- iii) Performance Security Deposit shall remain valid for a period of sixty days beyond the date of completion of contractual obligations of the bidder. This shall be returned after successful completion of the contract. In case non fulfillment of the contract, security amount so deposited can be forfeited in full or in part. Decision of the Director In charge in this regard shall be final. No Interest shall be paid on such deposit. Adjustment of balance of previous performance security against past bids, if any, will not be allowed.

10. Execution of agreement-

- a) A procurement contract shall come into force from the date on which the letter of acceptance or letter of intent is dispatched to the bidder.
- b) The successful bidder shall sign the procurement contract within a period specified in the bidding document or where the period is not specified in the bidding document then within fifteen days from the date on which the letter of acceptance or letter of intent is dispatched to the successful bidder.
- c) If the bidder, whose bid has been accepted, fails to sign a written procurement contract or fails to furnish the required performance security within specified period, the procuring entity shall take action against the successful bidder as per the provisions of the Act and these rules. The procuring entity may, in such case, cancel the procurement process or if it deems fit, offer for acceptance the rates of lowest or most advantageous bidder to the next lowest or most advantageous bidder, in accordance with the criteria and procedures set out in the bidding documents.
- d) The bidder shall be asked to execute the agreement on a non judicial stamp of specified value 500/- at its cost.

11. Bid shall be valid

- a. 90 days from the opening of technical bids..
- b. Subsequent to acceptance of bid, the rate shall remain valid throughout the

contract Period or for the period for which bids are invited whichever is higher.

12. Right to vary quantity- If the procuring entity does not procure any subject matter of procurement or procures less than the quantity specified in the bidding documents due to change in circumstances, the bidder shall not be entitled for any claim or compensation except otherwise provided in the bidding documents.
13. If the rate contract holder, its affiliates and associates quotes / reduces its price to render similar goods, works or services at a price lower than the rate contract price to anyone in the State at any time during the currency of the rate contract, the rate contract price shall be automatically reduced with effect from the date of reducing or quoting lower price, for all delivery of the subject matter of procurement under that rate contract and the rate contract shall be amended accordingly. The firms holding parallel rate contracts shall also be given opportunity to reduce their price by notifying them the reduced price giving them fifteen days time to intimate their acceptance to the revised price. Similarly, if a parallel rate contract holding firm reduces its price during currency of the rate contract, its reduced price shall be conveyed to other parallel rate contract holding firms and the original rate contract holding firm for corresponding reduction in their prices. If any rate contract holding firm does not agree to the reduced price, further transaction with it, shall not be conducted.

14. The bids should be submitted along with samples, if required.

15. Liquidated Damages:

- (i) If the contractor fails to execute the order/contract within the period specified in the bid, and if such failure have arisen from, any unforeseen cause such as strike, fire, accident, any natural calamity resulting in stoppage of work in the factory, of the Manufacturer or similar reasons which the Director In charge of RSGSM Ltd. may feel valid for an extension of the time, may extend the period without charging any liquidated damages. His decision shall be final regarding the sufficiency or otherwise for extension of time.
- (ii) If the Bidder fails to execute the order/contract within the period specified in the bid, the Director In charge of RSGSM Ltd may at his discretion allow extension of time subject to recovery from the Bidder as liquidated damages with 18% GST and not by way of penalty, a sum equal to the following percentage of the value of goods which the Bidder has failed to supply for the period of delay as stated below:-
 - a) Delay up to one fourth period of the prescribed delivery period – 2.5% + 18% GST

- b) Delay exceeding one fourth but not exceeding half of prescribed delivery period – 5% + 18% GST
- c) Delay exceeding half but not exceeding three fourth of the prescribed delivery period – 7.5% + 18% GST
- d) Delay exceeding three fourth but not exceeds the period equal to the prescribed delivery period – 10% + 18% GST

Notes :

- (a) Fraction of a day in reckoning the period of delay in supply shall be eliminated if it is less than half a day.
 - (b) The maximum amount of liquidated damages shall be 10%.
 - (c) When the successful Bidder is unable to complete the order/contract within the specified or extended period, the Company shall be entitled to accept supply from the open market without giving any notice to the Bidder but at his risk and cost i.e. Bidder's account and risk the goods or any part thereof which the Bidder has failed to supply or if not available the best and nearest available substitute thereof or to cancel the contract and the Bidder shall be liable for any loss or damage which the company sustained by reason of such failure on the part of the Bidder. But the Bidder shall not be entitled to any gain on such purchase made against default. The recovery of such damage shall be made from any sum accruing to the Bidder under this or any other contract with the Company. If recovery is not possible from the bills and the Bidder fails to pay the loss or damage within one month, the recovery shall be made under any law for the time being in force or from any other bills outstanding with the Company.
 - (d) If the supplier requires an extension of time in completion of contractual supply on account of occurrence of any hindrance, he shall apply in writing to the authority, which has placed the supply order, for the same immediately on occurrence of the hindrance but not after the stipulated date of completion of supply.
 - (e) Delivery period may be extended with or without liquidated damages if the delay in the supply of goods is on account of hindrances beyond the control of the bidder.
16. In the event of breach of the contract at any time on the part of the contractor/supplier, the contract may be terminated summarily by the Director In charge of the Company with such conditions as may be deemed fit.
17. All legal proceedings, arising out of this contract shall be subject to the jurisdiction of the courts situated at Jaipur city only.
18. In case of any dispute arising out of any matter related to the bid/contract/agreement, the matter will be referred to Sole Arbitrator appointed by Director

In charge, RSGSM whose decision shall be final and binding on both the parties. The place of arbitration shall be Jaipur. The fees and other expenses of the arbitrator shall be borne by both parties equally.

19. If the bidder resiles from his offer or offers new terms after opening of the bid, his Bid Security is liable to be forfeited with 18% GST.
20. **Procuring entity's right to accept or reject any or all bids-** The Procuring entity reserves the right to accept or reject any bid, and to annul the bidding process and reject all bids at any time prior to award of contract, without thereby incurring any liability to the bidders. Reasons for doing so shall be recorded in writing.
21. The bidder shall be responsible for the proper packing of goods so as to avoid damages under normal conditions of transport by road, sea, rail or air and delivery of the material in good conditions to the consignee at destination.
22. It is of the opinion that it is essential to evaluate the technical aspects of a bid before considering its financial aspect, call for bids in two envelopes, namely:-
 - (i) the techno-commercial bid containing the technical, quality and performance aspects, commercial terms and conditions; and
 - (ii) the financial bid containing financial aspects including the price.
23. In case the procuring entity calls for bids in terms of clause (b) of sub-section (1), the techno-commercial bid shall be opened and evaluated first and the financial bid of only those bids which have been found technically acceptable, shall be opened and evaluated.

If any Bidder or prospective bidder is aggrieved that any decision, action or omission of the procuring Entity is in contravention to the provisions of the Act or the Rules or the Guidelines issued thereunder, he may file an appeal to First Appellate Authority, as specified in the bidding Document within a period of ten days from the date of such decision or action, omission, as the case may be, clearly giving the specific ground or grounds on which he feels aggrieved:

Additional Conditions of Contract

1. Correction of arithmetical errors

Provided that a Financial Bid is substantially responsive, the Procuring Entity will correct arithmetical errors during evaluation of Financial Bids on the following basis:

- i. If there is a discrepancy between the unit price and the total price that is obtained by multiplying the unit price and quantity, the unit price shall prevail and the total price shall be corrected, unless in the opinion of the Procuring Entity there is an obvious misplacement of the decimal point in the unit price, in which case the total price as quoted shall govern and the unit price shall be corrected;
- ii. If there is an error in a total corresponding to the addition or subtraction of subtotals, the subtotals shall prevail and the total shall be corrected; and
- iii. If there is a discrepancy between words and figures, the amount in words shall prevail, unless the amount expressed in words is related to an arithmetic error, in which case the amount in figures shall prevail subject to (i) and (ii) above.

If the Bidder that submitted the lowest evaluated Bid does not accept the correction of errors, its Bid shall be disqualified and its Bid Security shall be forfeited or its Bid Securing Declaration shall be executed.

2. Procuring Entity's Right to Vary Quantities

- i. If the Procuring Entity does not procure any subject matter of procurement or procures less than the quantity specified in the Bidding Document due to change in circumstances, the Bidder shall not be entitled for any claim or compensation except otherwise provided in the Conditions of Contract.

- (c) when we fail to commence the supply of the goods or service or execute work as per supply/work order within the time specified;
- (d) when we do not deposit the performance security within specified period after the supply/work order is placed;and
- (e) if we breach any provision of code of integrity prescribed for bidding specified in the Act and Chapter VI of these rules.

In addition to above, the State Government shall debar us from participating in any procurement process undertaken for a period not exceeding three years in case where the entire bid security or any part thereof is required to be forfeited by procuring entity.

We understand this Bid Securing Declaration shall expire if :-

- (i) we are not the successful Bidder;
- (ii) the execution of agreement for procurement and performance security is furnished by us in case we are successful bidder;
- (iii) thirty days after the expiration of our Bid.
- (iv) the cancellation of the procurement process; or
- (v) the withdrawal of bid prior to the deadline for presenting bids, unless the bidding documents stipulate that no such withdrawal is permitted.
